In a 2023 survey conducted by the Thomson Reuters Institute, which gathered information from over 440 lawyers from large and mid-sized law firms in the United States, United Kingdom, and Canada, it was found that lawyers are cautious about the use of AI. When asked, 62% of the lawyers surveyed (80% for partners or managing partners) expressed concerns about using chatbots and generative AI in their work. Liz commented, "There are many risks associated with the use of AI in legal practices. These include both the quality of the output and the possibility of bias. The output is based on data, and it is only as good as the data human AI solutions are trained on, which can produce incorrect results if biased or incorrect." "Because AI requires access to data to analyze and base its output on, data security and intellectual property breaches are significant risks. This is because some sensitive data and intellectual property can be inputted into AI solutions, especially in the early stages, particularly for research purposes. However, the security of personal data and/or intellectual property, including the value of the data, can be compromised as it becomes publicly available, and therefore easily accessible to competitors and other users."

"A real risk presented by over-reliance on AI solutions for legal professionals is the absence of human reasoning in AI. Legal professionals are bound by ethical duties, and irresponsible use of AI can damage both civic duties and reputation. Important

principles for legal professionals when using AI solutions are critical thinking, professional skepticism, independent judgment, and responsible use. These principles will ensure that legal professionals engage their minds whenever they use AI solutions." It is essential for professionals in the industry to consider the risks of AI technology in their client work, as failure to do so can have significant consequences. Suppose a law firm provides incorrect information to its client, and the client relies on it, the firm is liable - which can be substantial. Lawyers need to understand that by sharing AI-generated information with their clients, they are effectively endorsing it, and therefore need to take full responsibility for the quality of that advice. Therefore, legal professionals will need not only to be proficient in the use of technology but also to verify its output before using it in live client projects, and also to be more aware of other risks associated with AI, such as privacy, security, bias, and discrimination. We have seen examples where sensitive client data can be leaked, and when using AI, the risk increases if appropriate controls for data security are not in place."

One example of how the use of AI in legal practices can create significant risks came to light in May 2023 when a lawyer in the United States found himself in trouble in court while representing an individual in a personal injury case. It was found that he had filed in a federal court where at least six cases were cited, which did not even exist. The reason for this extraordinary oversight? The lawyer relied on an AI chatbot to compile details for filing and failed to verify the authenticity of the sources used. Unfortunately, for the lawyer, his firm, and his client, the cases cited by the chatbot were fictitious, and the AI chatbot failed to create sources to verify its response. According to experts, this technology is notorious for generating misinformation. It is sometimes referred to as algorithmic bias. This occurs because it is creating content from a vast training data set in very simple terms."Concerns about the accuracy of AI-generated output have also been raised by Google's competing product board. Despite the technical behind-the-scenes technology developed by ChatGPT, the accuracy rate of identifying errors in AI-generated output is only 20%. OpenAI and others are now providing opportunities for commercial clients to train their own models based on their own data for more accurate output. Jenny believes that 'caution is needed because technology still relies solely on predictions. Jenny further said, "Managing the risks of inaccuracies in the use of AI technologies is related to the importance of carefully designing human and AI conversations and understanding how humans and

AI communicate with each other. One key risk management strategy is to ensure that those using technology speak to the IT team about how it works. Then they will understand that AI is essentially mimicking human intelligence by applying mathematics to large quantities of data.

According to the Law Society's report, "Future Skills for Law," there is a possibility of significant changes in the types of skills needed by law firms and in-house legal departments in the future due to automation, evolving client demands, and new generations of workplace technology. This is being achieved either by extending the applicability of existing laws (such as data privacy laws) to address these risks or by developing new laws to address these risks. For example, the United States is currently seeking public comments on responsible measures for AI.

"In addition, some international organizations are developing frameworks and guidelines to deal with risks, such as the proposed regulatory framework for AI being developed by the European Union, which will follow a risk-based approach. It is interesting to note that according to the 2023 AI Index from Stanford University, in 2022, 37 AI-related bills were passed globally, with the United States leading in passing nine laws.
